- 3. Add Part 1.8. F, Unit Prices Schedule. Items with the following paragraph:
 - 2. Item: Carry a cost of underground electrical service from existing meter kiosk between Bathhouse 5 & 6. This includes but not limited to: electrical trenching, bedding, backfilling, 4" PVC conduit, PVC sweeps, with pull string for final connection from remote meter to bathhouse 5 and 6 by the electrical contractor. Estimate distance from Bathhouse 5 to remote meter is approximately 175 LF and estimate distance from Bathhouse 6 to remote meter is approximately 275 LF for a total of 450 LF of underground electrical service.
