Scope of The Projects include preliminary engineering, survey, public involvement, right-of-way, final design, and associated environmental services for two (2) roadway improvement projects in the Town of Bristol. The limits of the 40636 (Summer Street, NH 104) project are approximately from School St. easterly 1.0 miles to Ayers Island Rd and the limits of the 41579 (Lake Street, NH 3A) project are approximately from Pleasant Street northerly 0.9 miles to the Mill Stream Park recreation trail. Improvements to Summer Street (NH 104) and Lake Street (NH 3A) include road widening or reconstruction and construction of an active transportation corridor, including streetscape elements to create improved bicycle and pedestrian facilities.
